## 30- 45 Markers Day 2014

### Conditions of Entry

1. Competition shall be played in accordance with the rules of golf, as adopted by the Royal and Ancient Club of St. Andrews, Scotland. Subject to such local rules as are in force on the East Geelong Golf course on the day of play
2. The event is restricted to female players holding a GA handicap between 30 & 45 on day of play
3. The East Geelong Golf Club Ladies Match Committee shall have full control of the competition and have the right to alter the conditions or starting times, or refuse entry to any person without being required to give any reason for such refusal.
4. The Match Committee will settle any dispute or protest. Such dispute or protest must be lodged not later than 15 minutes after conclusion of play. The Committee's decision is final.
5. Entries to be made on this entry form (or photocopy) with the full name/s of Competitor/s, Handicap/s, GolfLink number/s and entry fee/s
6. The competition for the day is Stableford.
7. **TROPHIES:** Individuals are entitled to win 1 trophy ONLY
8. In the event of a tie all winners will be decided by GA recommended countback system
9. **Distance Measuring Devices:** A player may obtain distance information by using a device that measures distance only. If during a stipulated round, a player uses a device that is designed to gauge or measure other conditions that might affect her play, (e.g. gradient, wind speed, temperature, etc) the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional function is actually used
