- PAYMENT AND ENTRIES TO BE FINALISED NO LATER THAN TUESDAY 17TH OCTOBER

Entries are restricted to Amateurs who are members of Clubs of Golf Victoria, or of Golf Clubs registered with State or Overseas Associations as are affiliated with or recognised by this association, or of Clubs affiliated with any Victorian Golf League. The Board shall have the right to refuse the entry of any person or team without being requested to give reason for such refusal.

- The competition shall be played in accordance with the Rules of Golf as are adopted by the Royal and Ancient Club of St. Andrews, Scotland, together with such local rules as are in force on the course over which the competition takes place. If a dispute should arise on any point, it shall be decided by the Board in charge of the competition, whose decision shall be final. Provided, however that

the Board, if in doubt, shall have the right to refer any such dispute to the Council of Golf Victoria, whose decision shall be final.

- The Board shall consist of the Board of the East Geelong Golf Club Inc. In the absence of a Full Board such members thereof, as may be present at the time, may give a decision and the decision shall be deemed to be the decision of the Full Board.
- Competitors shall be drawn against each other for the day in such a manner as the Board may arrange, or such person as the Board may authorise, shall have the power to select a partner for any Competitor whose partner is not at the first tee when called upon at the time to start.
- In the event of a tie, a countback, using the method recommended by Golf Australia, will decide the winning team or individual.
- The Board shall have the power to limit the number of players or teams and to alter their starting times. Players or teams must be prepared to play at any time fixed by the Board. Players should report to the starter at least 15 minutes prior to the advertised time.
- In the event of inclement weather, or for any other reason, the Board may cancel, shorten, or postpone to another day any event in this tournament.
- No Player is eligible to win more than one trophy in any event (excluding Teams events or Nearest to Pins). The Board shall have the right to allocate trophies.
- The use of Distance Measuring Devices are permitted.
- GST included in all entry fees.
